

**SPECIAL PROGRAM OF
PRELIMINARY TICKET SALES**
for performances of the ballet *Nutcracker* in the 242nd theatre season

In connection with increased demand, in the 242nd season the theatre developed a special program for the preliminary sales of tickets for the ballet *Nutcracker* for citizens purchasing tickets for **PERSONAL** visits to the performances.

1. Preliminary ticket sales will be carried out only at the ticket offices of the Bolshoi Theatre and only on the passport (birth certificate of the child) according to the following schedule:

Ticket sale for the performances from 23 to 28 December will be opened at the theater's ticket offices on 23 September 2017, starting from 10:00 (Msk)

1. **Preliminary ticket sales will be carried out on the passport of the buyer at the ticket office located in the management building of the Bolshoi Theatre. An individual can purchase no more than 2 (two) tickets and only for ONE single performance from the list above. The second ticket can be purchased only on a second viewer's passport (or a birth certificate if the second viewer is a child who does not have a passport). On the date of purchase an individual can provide a copy of passport, but on the date of the performance an individual should provide the original of the document of individual inscribed on the ticket.**
2. **In the following days, the sale of tickets not sold on the first day of preliminary sales will be carry out in accordance with the time schedule of the theater ticket offices in an ABSOLUTELY similar fashion to paragraph 2.**
3. **Members of large families have a right to purchase tickets for parents and all minor children in the order of arrival. On the date of purchase citizens of this category are required to provide a document confirming their status, and a passport of one of the parents, as well as passports (or birth certificate, if children do not have passports) of each viewer. Take into account that tickets for children are sold according to the recommended age, which subsequently guarantees them a presence at the performance (children under the age of 5 are not admitted to any Theatre events. Children ages 5 and over may visit matinees, children over 10 years of age may be admitted to the evening shows).**
4. **During the pre-sale of tickets for the performances listed above passports of buyers and all viewers will be verified in order to avoid re-purchase.**
5. **The ticket will be printed on a special form; all data of the viewer's passport (birth certificate of the child) will be indicated in a ticket and checked at the entrance to the theater on the day of the performance.**
6. **A ticket with corrections and/or considerable damage, or counterfeited by anymeans, is invalid. Any changes of data in the purchased tickets are not permitted. If a viewer can not attend a performance, he must personally submit an application specifying the reason and provide a passport (birth certificate of the child) to the theatre ticket office.**
